



ParlAmericas delegation to the General Assembly of the OAS

On June 19-21 2017, a ParlAmericas delegation observed the 47th Regular Session of the General Assembly (GA) of the Organization of American States (OAS), held in Cancun, Mexico on the theme of [Strengthening Dialogue and Concerted Action for Prosperity](#). The delegation was led by Senator **Marcela Guerra** (Mexico), President of ParlAmericas, and composed of legislators from Canada, Colombia, Ecuador, Grenada, Mexico, and Panama.

[Inter-American Commission on Human Rights \(IACHR\)](#), the [Inter-American Court of Human Rights](#), the [Inter-American Commission of Women \(CIM\)](#) and the [Inter-American Juridical Committee \(IAJC\)](#), as well as the adoption of declarations and resolutions put before the General Assembly.

As part of their program, members of the ParlAmericas delegation also attended the Dialogue with Civil Society Representatives and Other Actors, the Meeting of the [Summit Implementation Review Group \(SIRG\)](#) and panel discussions on: (1) Integral Development and Prosperity in the Hemisphere, (2) Opportunities and Challenges for Women’s Leadership in the Americas, and (3) Multidimensional Security.

The delegation made an intervention at the Dialogue on the Rule of Law and Environmental Justice, a parallel session organized by the Government of Mexico, where the President of the ParlAmericas Parliamentary Network on Climate Change (PNCC), Member of the National Assembly **Javier Ortega** (Panama), delivered remarks on the importance of a coordinated approach between all social actors and institutions – including the parliamentary branch of government – to combat climate change. Mr. Ortega also announced the

The participation of ParlAmericas at the OAS General Assembly is guided by two objectives: to raise awareness about the function and contributions of parliaments in turning executive commitments to concrete and funded public policy actions; and to provide an opportunity for individual parliamentarians to gain a better understanding of issues that are currently being discussed within the OAS, and their effects on countries and citizens across the Hemisphere.

The ParlAmericas program included attendance at all of the plenary sessions, beginning with the official inauguration of the General Assembly which included a keynote address by his Excellency **Enrique Peña Nieto**, President of Mexico. Delegates were then present at the Foreign Ministers Dialogue, and the plenary session which featured reports on the work of the

upcoming publication of two complementary resources that ParlAmericas has developed in collaboration with the OAS Department of Sustainable Development (DSD), entitled: [Climate Change: A Comparative Overview of Rights Based Approach in the Americas](#); and [Climate Change: A Comparative Overview of Legislative and Executive Responses in the Americas](#).

In addition to accompanying the formal agenda of the General Assembly, the ParlAmericas program also included a series of bilateral meetings with OAS officials, and Ministers of Foreign Affairs.

Members of the ParlAmericas delegation engaged in separate dialogue sessions with the following OAS officials: (1) [Secretary General Luis Almagro](#); (2) [Assistant Secretary General Nestor Mendez](#); (3) [Secretary for Strengthening Democracy Francisco Guerrero](#); and (4) [Secretary for Hemispheric Affairs James Lambert](#). These discussions addressed the current work of the OAS in the hemisphere, with a particular emphasis on the ongoing dialogue amongst OAS Member States regarding the situation in Venezuela and the role of the OAS in supporting a peaceful political solution. The value of engaging the parliamentary branch in the Inter-American system and the importance of a strengthened strategic relationship between ParlAmericas and the OAS to foster synergies in the work of both institutions were also discussed in relation to thematic issues of mutual interest.

Delegates addressed how the work of ParlAmericas in strengthening parliaments complements efforts of the OAS to build more efficient, transparent and inclusive institutions. They also further reinforced the message that ParlAmericas is the only institution that was created by

national parliaments of the OAS Member States with the explicit mandate of facilitating participation of the parliamentary branch in the Inter-American system; this sets ParlAmericas, and its engagement with the OAS and Summit of the Americas process, apart from other inter-parliamentary entities in the region.

Over the course of the OAS General Assembly, members of the delegation also met briefly with the Canadian Minister of Foreign Affairs **Chrystia Freeland**, the Ecuadorian Minister of Foreign Affairs and Human Mobility **Maria Fernanda Espinosa**, the Guyanese Vice-President and Minister of Foreign Affairs **Carl Greenidge**, the Jamaican Minister of Foreign Affairs and Foreign Trade **Kamina Johnson Smith**, and the Panamanian Vice-President and Minister of Foreign Affairs **Isabel de Saint Malo**.

On the final day of the program, the ParlAmericas delegation held a dialogue session with the host of the 47th OAS General Assembly, Mexican Secretary of Foreign Affairs **Luis Videgaray**. The importance of multilateral fora to support political dialogue on pressing regional issues like the situation in Venezuela was discussed. Secretary Videgaray underlined the valuable role of ParlAmericas in providing a necessary forum for parliamentarians to engage in the Inter-American system. This, in his view, reinforced the essential norm that respect for all three branches of government – Executive, Legislative and Judicial – is fundamental for democracy. The dialogue concluded with an agreement that the ParlAmericas delegation would issue a [statement for the guarantee of security of Venezuelan parliamentarians](#) who had attended the General Assembly.

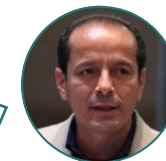
