Given this scenario, it is crucial that parliamentarians in the Americas and the Caribbean engage in global discussions on the governance of artificial intelligence based on an informed approach that considers its benefits and risks in order to pave the way for these technologies to build fairer, more democratic, inclusive, and sustainable societies.

The rapid development of artificial intelligence has made it clear that its impacts must be analyzed and addressed from multidimensional and innovative legislative approaches that prioritize the rights of users and consumers and consider central issues such as privacy, data protection, transparency, mainstreaming a gender perspective into algorithmic accountability, intellectual property rights, and ethics.
