The dialogue will be structured in two thematic rounds followed by an opportunity to provide final reflections. Parliamentarians, civil society, and youth representatives will be invited to share their perspectives on priority issues and challenges that relate to addressing inequalities to enable climate ambition, thereby contributing to shaping parliamentary action on these issues.

Round 1 - Inclusive Climate Action: Climate action should be transparent and designed with an intersectional lens ensuring that policies and programmes are meaningfully designed in consultation with communities and respond to the needs of traditionally marginalized populations, making certain that these do not further exacerbate inequities. The transition to a more environmentally sustainable society should be rooted in climate justice, and seek to improve community resilience, ensure a just transition, and leave no one behind.

Round 2 – Action for Climate Empowerment: This concept originated from article 12 of the Paris Agreement, to promote efforts to build understanding and capacity of all members of society to improve their engagement in climate action by strengthening public policies in six focus areas: education, training, public awareness, public participation, public access to information, and international cooperation.
