

## Select Standing Committee on Finance and Government Services: Annual Budget Consultation

### Budget 2019 Consultation

Online registration for public hearings opens Friday, September 7 at 9:00 a.m.  
Written, audio and video submissions, and the online survey will open September 17.  
The consultation will close on Monday, October 15 at 5:00 p.m.

Every fall, the all-party **Select Standing Committee on Finance and Government Services** holds a public consultation on the next provincial budget. From mid-September to mid-October, British Columbians are invited to share their thoughts, ideas and priorities. The Committee reviews all the input received to make recommendations to the Legislative Assembly for the next provincial budget.

### Why does the Committee consult on the provincial budget?

The **Budget Transparency and Accountability Act SBC 2000, c.23** requires a select standing committee of the Legislative Assembly to hold a budget consultation and report on the results by November 15 each year. The Legislative Assembly has assigned this task to the all-party Select Standing Committee on Finance and Government Services.

As part of the consultation, the Act also requires the Minister of Finance to release a budget consultation paper which is referred to the Committee. It outlines the province's fiscal forecast, key budget issues and how British Columbians can share their views. This paper must be released by




