# TERMS OF REFERENCE (2016-2017)

#### Mandate

The Gender Equality Group is responsible for providing guidance and oversight on ParlAmericas' women's rights and gender equality programming. It will make recommendations to the gender program staff at the ParlAmericas Secretariat on the development of strategic objectives and annual work plans (calendar of activities, thematic priorities) as well as the follow-up on commitments made in different Annual Gatherings.

The President of the Group of Women Parliamentarians (GoWP) reports on the Group's work to the Board of Directors of ParlAmericas.

## Membership

The Gender Equality Group is composed of the GoWP Executive Committee (President, Vice-President and Secretary) in addition to 3-5 members at large.

Executive Committee members are elected for two-year terms during the Plenary Assembly of ParlAmericas. The GoWP President is also a 2<sup>nd</sup> Vice-President of ParlAmericas with the right of vote on the Board of Directors of the organization (see Chapter XIV of the <u>ParlAmericas Regulations</u>).

Group members at large are national parliamentarians from ParlAmericas' membership, appointed by the Executive Committee following an open application process. Applications will be reviewed by ParlAmericas' gender program staff in order to make recommendations to the Executive Committee based on the objective of diverse representation: youth, gender (the Group will aim to have a minimum of one male member) and subregion (North, Central and South America and the Caribbean).

#### Meetings

Gender Equality Group members will meet annually, on the margins of the Plenary Assembly of ParlAmericas.

The Group will engage in ongoing communications as needed via email, chat group or Skype conference, facilitated through the ParlAmericas Secretariat. As needed, members can also provide recommendations individually based on their background and expertise.
